6. Accidental release measures.

6.1. Personal precautions, protective equipment and emergency procedures.

Eliminate sources of ignition (cigarettes, flames, sparks, etc.) from the air in which the leak occurred. If there are no contraindications, spray solid products with water to prevent the formation of dust. Use breathing equipment if fumes or powders are released into the air. Block the leakage if there is no hazard. Do not handle damaged containers or leaked product before donning appropriate protective gear. Send away individuals who are not suitably equipped. 7. Handling and storage.

7.1. Precautions for safe handling.

8.2. Exposure controls.
